the evening of June 11, 2013. 30 homeowners representing more than 21 townhomes attended and a quorum was present.

After thanking the members of the 2012-2013 board, President Sandy Dresser thanked whoever is responsible for keeping our cluster free of cicadas this year and noted that our cluster successfully raised a litter of foxes this spring (they eat squirrels, mice, rats, etc.) and is home to at least one mating pair of bluebirds who are living in one of our birdhouses near the river garden behind Courtyards E and F.

Sandy and the attendees sincerely thanked Bob Williamson and Scott Bornman for managing the pavement resealing work so efficiently and Gary Villhauer for managing the drainage work so well. There was general agreement that the cluster has never looked better, which is a tribute to all of us. Members elected Joe Durishin to fill a vacant position on the board of directors.

The highlight of the meeting was a presentation from two of the "founding fathers" of RescueReston, John Pinkman and David Stroh. John focused on the critical importance of the effort to prevent commercial redevelopment of the golf course not only to our quality of life but to the very idea and ideals of Reston. He said that the most important single thing we can do to effectively counter this threat is to show up at the County Board of Zoning Appeals (BZA) hearing on Wednesday Sept. 25th wearing our RescueReston t-shirts and carrying our RescueReston signs. Dave noted that the BZA hearing is only step 1 in the process. Whichever side loses is sure to appeal, first to the Board of Supervisors and then to the Circuit Court. We and all Restonians need to be prepared to fight the good fight as long as it takes.

Both men noted that it's still hard to decipher what strategies the other side may be considering. They both assured us that Reston Association is fully involved in and committed to defeating the redevelopment threat. Further they encouraged all of us to communicate to Supervisor Catherine Hudgins how strongly we feel about keeping commercial redevelopment out of our neighborhood.

Mosquito season is upon us. It's important that each of us do what we can to minimilize the nuisance by routinely emptying every possible source of standing water in which they can breed—birdbaths, flowerpot trays, tarps, ashtrays, buckets, etc. etc.

Some Things To Think About

In recent weeks residents have suggested a couple of ideas for our mutual consideration that were not discussed at the annual meeting. The board will be considering these issues in the coming months and your thoughts and interests are central to these discussions. We urge you to talk to us and let us know how you feel about these possible improvements/ changes to our neighborhood.

Implement parking permits

including both resident and visitor permits (before the Wiehle Avenue metro station opens) to aid in identifying (and towing) the cars of those who try to park in our neighborhood and walk to the metro.

A related issue is whether or not to lead/encourage a cooperative effort with our neighbors in Golf Course Square and Newbridge and Reston Association to petition the County to designate Golf Course Square a Residential Parking District instituing permit-only parking on the street leading into our cluster.

to supplement current Cluster communications and provide a forum for residents to exchange ideas, sell or give away items no longer needed, and solicit recommendations regarding contractors, etc.
