# 2014 Assessments Due in January

This month, you'll receive your 2014 assessment statement in the mail.

The annual assessment is \$1,020. The first quarterly installment of \$255 is due January 15, 2014 Subsequent payments will be due April 15, July 15 and October 15.

If you prefer to pay your annual assessment in a single payment, you'll receive a 10% discount if you make your payment by February 1, 2014 In this event, your payment amount will be \$918. (Note, the discount is not available for lump-sum payments postmarked after February 1st.)

# Christmas Tree Recycling

If you want to **recycle** your Christmas tree this year, VHI will be picking them up in our neighborhood on **Thursday**. **Jan. 2, and Wednesday. Jan 9.** To participate, your natural tree must be stripped of all decorations and placed on the curb by **7:00** am on one of those dates.

You can also put your tree out for **disposal in the land-fill** on any regular trash collection day. **To be picked up as trash**, your tree must be cut in no more than 4 foot lengths and either tied in a bundle or placed in a trash can.

### Snow Services Procedures

We made it through the first snow event of the season, but it still seems useful to review our Cluster snow policy. The Cluster provides snow services that are intended to make it possible for us to drive our cars out of and back into our parking spaces safely. There should be no expectation of seeing bare pavement until the snow has melted.

Plowing is done by a truck with a blade, and the truck is limited as to how and where it moves snow. There will inevitably be some snow ridges left behind some cars. Therefore, it's wise to wait until <u>after</u> the plow has been here to shovel out your car and parking space.

Unless there is a massive snow accumulation, snow services do not include removal of snow with a front loader, so there will be piles of snow left in empty parking spaces and along the edges of the street and lots.

The road and parking lots will be plowed when there is 4" of snow on the ground.

Sand and salt will be applied to the road and parking lots when there is a threat of icing.

No snow shoveling is included in our snow services contract. We are all responsible for shoveling our own walks, and the residents of each courtyard are responsible for clearing and maintaining a walkable path along the sidewalks that border the parking lots. If you are unable to shovel your own walk or need help getting your car out, talk to a neighbor or contact any board member. We'll find some help for you.
