Falling Leaves

The leaves are turning, which is lovely, but they are also beginning to fall—along with needles from the pine trees and this year's crop of acorns. For those of you who are new to the neighborhood, falling leaves and acorns are the price we pay for the luxury of our beautiful trees. Our landscape maintenance crew will do two clean-ups of leaves on common property. The first clean-up will be done when about 50 percent of the leaves are down. This is usually in mid-November. The second clean-up will be done when the trees are essentially bare, usually in mid-December. We've asked the crew to blow acorns off our sidewalks each time they visit the cluster, but we all need to be aware that walking on acorns is like walking on marbles. They can be dangerous.

Residents are responsible for raking up and disposing of leaves and needles on our own property and on the sidewalks in front of our houses. Our trash company is required to pick up our bags and cans of leaves on every regular trash day.

New Golf Course Hearing Date

The Circuit Court hearing of the appeal of the Board of Zoning Appeals decision has been rescheduled for Friday, November 6th. We understand that the hearing will be held in the judge's chambers.

The hearing addresses a largely procedural issue. The judge has been asked to rule not only on whether the petitioners (Reston Association, Fairfax County, the Affected Homeowners) had standing to appeal the decision the Board of Zoning Appeals (BZA) made last April, but also whether the golf course owners had standing to appeal the County Zoning Administrator's determination in June of 2012 in the first place, as well as whether the BZA had standing to render an opinion on the golf course owners' appeal. The key point, in all instances, being that the golf course owners have never submitted an actual development plan.

We'll let you know the judge's decision as soon as we get the news.

Change in Towing Contractors

Happily we rarely need to have an illegally parked car towed, but when we do, we need a company we can rely on to be responsible and honest. The company we've been using, East Coast Towing, limited its business to parking management for residential communities and was attuned to our particular interests and concerns. Unfortunately they recently merged with Henry's Towing, a company with an unsavory reputation and a focus on answering police calls.

We have, therefore, signed an agreement with Battlefield Towing to handle our rare but necessary towing. Under our agreement. Battlefield will respond only to calls placed by the president or vice president of the cluster to pick up cars parked in violation of our parking rules. They are not authorized to patrol the cluster and remove cars they deem to be illegally parked.

Shorter Days Mean Darker Streets and Courtyards
