## Tree Work To Inconvenience Some

Next Friday (June 30th) JL Trees is scheduled to do some tree work in the neighborhood. Some of the work will be in trees that overhang assigned parking spaces, and some residents' cars will need to be moved out of the way—not only to protect the cars, but also to make room for the trucks and equipment.

**In Courtyard A**, we will be taking down the maple tree in front of 2080 and pruning overhanging limbs in the maple tree in the bed beside the courtyard sign. If you live at **2078, 2080, 2082, 2084, 2086, 2088 or 2090**, you will need to move your cars.

**In Courtyard E**, we will be pruning deadwood from the pin oak in the back righthand corner in front of 2115. Affected residents are those who live at **2113, 2115, 2117, 2119, 2121, and 2123**.

**In Courtyard F**, we will be pruning deadwood from the pin oak in the back lefthand corner in front of 2157. Affected residents are those who live at **2155, 2157, 2159, 2161, and 2163**.

**If you are one of those affected, please make sure your car is moved out of your space no later than 8:00 A.M.** on Friday, June 30th.

## Cluster Annual Meeting Held

The Annual Meeting of the Cluster Association was held the evening of Monday June 12, 2017. Thirty-six residents attended and a quorum was present. There were no candidates for positions on the board and the current directors will continue to serve.

President Sandy Dresser presented a brief review of the 2016-2017 board year and noted that a formal Reserve Study was in progress.

Resident Jim Myers raised the issue of increased population density being considered for Reston by the Fairfax County Zoning Administration. He asked residents to pay particular attention to proposals being circulated that would add increased residential density around the Village Centers (South Lakes, Hunter Mill, Tall Oaks and Lake Anne in particular) which are definitely not located in the metro/commercial core of Reston.

Resident John Pinkman spoke on the current status of the proposed sale of the golf course. He noted that Northwestern Mutual was still marketing the property as a potential redevelopment site, but that the permanent open space designation is firmly in place. He then reminded us that Rescue Reston is still paying off the attorney's fees incurred in the appeal process and asked for volunteers to assist in putting on the Rescue Reston Golf Tournament to be held again this fall.
